The purpose of the planning board is to review and approve new subdivisions in the County. They also hear, and consider, testimony from applicants regarding items such as Special Use requests, proposed re-zoning actions and amendments to the various ordinances adopted in the County. The Board members consider this testimony and then pass along a recommendation to the Board of Commissioners for the request to be approved or denied.
