



## INTERNSHIP PROGRAM

**Program:** The Summer and Regular Internship programs with Northampton County Government, is an 8-week non-paid internship that provides students and adults with a unique opportunity to learn how local government departments and agencies operate. The program will provide work experience and knowledge. Students will gain professional experience in their assigned county department, develop a comprehensive perspective on the mission and vision of Northampton County, and opportunities for networking and professional development.

**Mission:** To provide our citizens with on-the-job training and professional development to prepare them for the workforce or to re-enter the workforce.

### **Program Dates:**

The Summer Internship program will be held from June 15 to August 15. The application deadline is May 30.

The Regular Internship program will be held from February 15 to April 15. The application deadline is January 30.

### **Requirements:**

- Northampton, Halifax, or Hertford County Resident
- Subject to Criminal Background Check
- Subject to Drug/Alcohol Testing
